

**CITY OF ARAB, ALABAMA
ORDINANCE NO. 2020-3**

**AN ORDINANCE DESIGNATING THE POLLING PLACE FOR ALL MUNICIPAL ELECTIONS
HELD WITHIN THE COPORATE LIMITS OF THE CITY OF ARAB**

WHEREAS, the City of Arab has held past municipal elections at two polling places located at the Arab Community Center precinct 26 boxes 1 and 4, and The Arab Recreation Center precinct 26 boxes 2 and 3, and

WHEREAS, the Arab Community Center was declared to be unsafe for public use due to structural damage and ordered to be demolished by the City of Arab on April 16th 2018, and

WHEREAS, after consultation with the Marshall County Probate Judge, the District One Commissioner and the City of Arab, the Marshall County Commission has determined to consolidate the Arab precinct 26 into one polling location, and

WHEREAS, after consultation with the City Arab and the Marshall County Probate Judge, the existing polling place at the Arab Recreation Center has insufficient parking to accommodate voting for all the residents of the Arab area, and

WHEREAS, after consultation with the Marshall County Probate Judge, the District One Commissioner and the City of Arab, the Marshall County Commission has determined that the most suitable location for a single polling place in the City of Arab is the Arab Senior Center located at 800 North Main Street, Arab, Alabama, and

WHEREAS, the Marshall County Commission is charged with the responsibility of designating the polling places within the assigned precincts pursuant to Section 17-6-4, Code of Alabama (1975) and have designated the Arab Senior Center as such single voting location within the City of Arab by resolution dated March 28, 2018, and


WHEREAS, the City Council of Arab, pursuant to §11-46-24 Code of Alabama (1975), is responsible for designating voting locations within the city limits.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ARAB, ALABAMA THAT:

1. All Municipal Elections will be held at the Arab Senior Center located at 800 North Main Street Arab, Alabama as the Polling Place for Precinct Number 26, boxes 1 through 4 as determined by the Marshall County Commission pursuant to Section 17-6-4, Code of Alabama (1975).
2. All other Ordinances, or parts of Ordinances, in conflict herewith are hereby repealed.
3. The City Clerk of the City of Arab, Alabama shall certify the adoption of this Ordinance, and cause the same to be published as required by law; and this Ordinance shall take effect and be in force from and after its adoption and publication as required by law.


